Eligible invoice period: January 1 - March 31, 2026

Rebate Program Qualifications and Claiming:

1. Visit the PSN site at www.fordpsn.com beginning on April 21, 2026 through May 31, 2026 to claim all rebates for the Q1 2026 program.
2. You must register to become a PSN member by February 28, 2026 and receive account approval by March 31, 2026 in order to be eligible for the Q1 2026 program.
3. Log in to view your eligible rebates.
4. You will receive payout via the PSN Award Card.

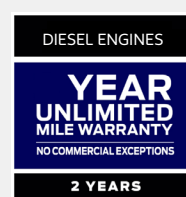
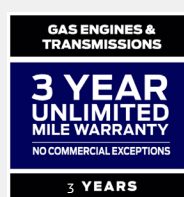

PSN Award and Rebate Card will be issued within 2-4 weeks from claiming of rebate within PSN. Award Cards will be issued in the business name.
